

SPORTCHEER SCOTLAND NATIONAL TEAM LIABILITY, MEDICAL, PUBLICITY RELEASE AND WAIVER FORM

Every athlete must consent and agree to the below in order to participate in competitions, camps, conferences, tryouts, auditions, training and performances.

LIABILITY RELEASE

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, I (parent/guardian if under 18 years) grant the permission necessary to allow myself/my child to participate in a competition, camp, conference, tryout, audition, training or performance conducted by SportCheer Scotland. I further agree to release and to hold harmless SportCheer Scotland from any and all liability whether caused by negligence or otherwise for any claim, judgment, loss, liability, cost and expenses (including, without limitations, legal fees and costs) arising out of or connected with the competition, camp, conference, tryout, audition, training or performance including any claim arising out of or connected with any illness or injury that I/my child may incur or sustain during the competition, clinic, conference, tryout, audition, training or performance. SportCheer Scotland are not responsible for any property that participants may bring to classes or events. Lost Property will be left at all venues.

MEDICAL RELEASE

SportCheer Scotland strive to provide the maximum in safety procedures for all skills taught. However, I understand that the sport of cheer, performance cheer, cheerleading and it's disciplines subjects myself/my child to the possibility of physical illness or injury I also hereby acknowledge the risks involved when taking part in the sport of cheer, performance cheer, cheerleading and it's disciplines. I, on my own/my child's behalf acknowledge and agree that such participation in a competition, camp, conference, tryout, audition, training or performance subjects myself/my child to the possibility of physical illness or injury I also hereby acknowledge the risks involved when taking part in cheerleading and dance, and have the necessary insurance cover in association with my team/club or have individual athletic insurance to cover such, in the event of an injury, accident, or loss when taking part. In the event of such illness or injury, I authorise SportCheer Scotland to obtain necessary medical treatment for myself/my child and release and hold harmless SportCheer Scotland in the exercises of this authority.

I also confirm that I / my child, have not been advised by a doctor to avoid physical exercise and do not know of any problems that may affect my / my child's health when taking part at the event.

PUBLICITY AGREEMENT

Therefore, without reservation or limitations, I, on my own behalf/my child's hereby assign, transfer and grant SportCheer Scotland exclusive right to photograph and/or videotape, audiotape myself/my child, and give permission for such photographs, video and audio tapes to be used in print or broadcast through any media which is deemed appropriate for the promotion of SportCheer Scotland.
