Role Summary

The Director Representative of the Athletes will be a member of the SCS Board of Director and be responsible for representing the interests and opinions of Scottish cheerleaders. They will also lead in developing social media content, particularly related to the National Team. Directors may chair sub-committees and will perform other such duties as established by the Board.

Responsibilities

Responsibilities Director Representative of the Athletes will be responsible for:

- Representing the interest of SportCheer Scotland cheerleaders at quarterly board meetings and other relevant events where required.
- Developing and maintaining relationships with member athletes.
- Chairing athlete forum to give a voice to Scottish athletes and reporting findings to Board Members
- Attending a minimum of two quarterly board meeting per annum and the Annual General Meeting.
- Attending ICU World Cheerleading Championships to represent Scotland at Athlete Commission.
- Lead content creator for SportCheer Scotland and Team Scotland social media, including a social media plan.
- Aiding the strategic development of cheerleading in Scotland including planning and implementation of initiatives and programmes.
- Promotion of SportCheer Scotland and its membership.
